

#### Test of the True Redeemer – Must Fulfill 5 Roles

Christ fulfilled the 'Goel' or Redeemer's roles in all these 5 areas:

Matthew 20:28 - Universal Law

Even as the Son of man came not to be ministered unto, but to minister, and to give his life a <u>ransom</u> for many.

- 1. The obligations of the 'Goel' included the duty to <u>redeem</u> the relative from <u>slavery</u>, if the latter had been obliged to sell himself into serfdom.

  Leviticus 25 Book and Chapter of the Sabbatical Year and Jubile.
- 2. To <u>repurchase</u> the property of a relative who had had to sell it because of poverty. Leviticus 25 Book and Chapter of the Sabbatical Year and Jubile.
- 3. To <u>avenge</u> the blood of his relative. Deuteronomy 19:6, 12.
- 4. To <u>marry</u> his brother's widow in order to have a son for his brother, in case the brother had not got any son to pass his name forth. Deuteronomy 25:5-6.
- 5. To <u>receive</u> the restitution if the injured relative had died. Numbers 5:8.

# Precedent - Compelled Speech by Court - 1

Pastor Arthur Pawlowski – Pastor in Calgary, Alberta, Canada "The Polish-Canadian pastor who has been jailed for holding church services in Calgary, Alberta, said he will refuse to obey a court order mandating him to publicly echo the established opinions of medical experts regarding COVID-19.

<u>Pastor Artur Pawlowski</u> was sanctioned by Court of Queen's Bench Justice Adam Germain to 18 months of probation, according to a written ruling released Friday. The ruling is the latest development in Alberta's ongoing legal battle against Pawlowski, who faced a civil contempt charge for holding church services in violation of a <u>court order</u> forbidding organizing, promoting or attending an "illegal public gathering."

He faced another contempt charge for repeatedly ejecting armed officials attempting to inspect his sanctuary for COVID-19 compliance, for which he first drew <u>international</u> <u>attention</u>." In addition to tens of thousands of dollars in costs and fines, one condition of Pawlowski's probation requires him to parrot "the majority of medical experts in Alberta" regarding social distancing, mask wearing and vaccines, even when he speaks in church...."

# Precedent – Compelled Speech by Court – 2

Pastor Arthur Pawlowski – Pastor in Calgary, Alberta, Canada ".... Pawlowski told Fox News he has no intention of complying with Germain's sanction, which he condemned as "unconstitutional," "illegal," and a clear instance of "compelled speech like in China and North Korea." "This crooked judge wants to turn me into a CBC reporter or CNN reporter, that every time that I am in public, every time I'm opening my mouth, I am to pray their mantra to the government," he said.

Pawlowski said the judge's condition is "without precedent" in Canada, an assertion echoed by his lawyer, Sarah Miller, who described Germain's sanction as "bizarre" and "likely unconstitutional" under Section 2 of the Canadian Charter of Rights and Freedoms, which guarantees freedom of expression. "This is totally and wholly new as far as sentencing goes, as far as I can see or as far as I am familiar with," Miller told Fox News. "I've never heard of any kind of probationary period which includes conditions that compelled certain speech. It seems highly unusual and rare."

# How to File against a Charge Served Under the New World Religion

- 2<sup>nd</sup> Charge: Category relating to Doctrines
- You have decided to respond to this charge as a Defendant/Respondent
- Examine carefully the following Forms you need to fill up and serve them to the appropriate courthouse.

# Starting a file/Responding to a file

# Are you starting a file as a Self-Represented Litigant (SRL)? (Plaintiff/Applicant)

#### Paperwork (forms) needs to be prepared by you

- A file will be generated by the courthouse (fees may need to be paid) in order to apply to the court
- The file will need to be "served" or given to the other parties (Defendant(s), Respondent(s), etc)
- Once the other parties have opportunity to "respond" (if they choose to defend the action/application) the instituting party may "respond" to any new information raised by the other parties (IF they respond) This is typically called a "Reply" (Form).
- Once the parties have filed all the initial paperwork, there is a period of "discovery" where documents are exchanged/served, prior to trial. There may also be mediation necessary.

# Wanting to respond as a SRL? (Defendant/Respondent)

# Paperwork (forms) needs to be prepared by you

- 1) Paperwork (forms) needs to be prepared
- 2) Answer/Response/Defence will need to be "served" (sent to the originating party) then filed at the courthouse. A fee may need to be paid to respond/file at the courthouse.
- Enter "discovery" process.
- 4) Wait for trial.

#### Ezekiel 18:20

The soul that sinneth, it shall die. The son shall not bear the iniquity of the father, neither shall the father bear the iniquity of the son: the righteousness of the righteous shall be upon him, and the wickedness of the wicked shall be upon him.

Step 2. <u>Illustrate</u> the Universal Law with the 5 Roles of the Redeemer

Role 1. The obligations of the 'Goel' included the duty to redeem the relative from slavery, if the latter had been obliged to sell himself into serfdom. – Leviticus 25:48-49.

"And thy brother that dwelleth by him wax poor, and sell himself unto the stranger or sojourner by thee, or to the stock of the stranger's family: After that he is sold he may be redeemed again; one of his brethren may redeem him: either his uncle, or his uncle's son, may redeem him, or any that is nigh of kin unto him of his family may redeem him."

"Through Adam's sin, his posterity felt under the condemnation of the Moral Law, for "sin is the transgression of the law" 1 John 3:4. Man became slave to Satan, unable to free himself. Christ, in his role of 'Goel' or Redeemer and by taking upon His divine nature, our fallen human nature, identified Himself with us, by becoming the Elder Brother of our race and redeeming us as the Nearest of Kinsman, from the bondage and slavery of sin." https://144000teachers.org/wp-content/uploads/2021/06/True-Meaning-of-and-Role-of-the-Redeemer-Edited-3.pdf

Role 2. To repurchase the property of a relative who had had to sell it because of poverty. – Leviticus 25:23-26.

"The land shall not be sold for ever: for the land is mine; for ye are strangers and sojourners with me. And in all the land of your possession ye shall grant a redemption for the land. If thy brother be waxen poor, and hath sold away some of his possession, and if any of his kin come to redeem it, then shall he redeem that which his brother sold."

"After his expulsion from Eden Adam's life on earth was filled with sorrow. Every dying leaf, every victim of sacrifice, every blight upon the fair face of nature, every stain upon man's purity, were fresh reminders of his sin. Terrible was the agony of remorse as he beheld iniquity abounding and, in answer to his warnings, met the reproaches cast upon himself as the cause of sin. With patient humility he bore for nearly a thousand years the penalty of transgression. Faithfully did he repent of his sin and trust in the merits of the promised Saviour, and he died in the hope of a resurrection. The Son of God redeemed man's failure and fall; and now, through the work of the atonement, Adam is reinstated in his first dominion....

....The Saviour leads him to the tree of life and plucks the glorious fruit and bids him eat. He looks about him and beholds a multitude of his family redeemed, standing in the Paradise of God.... This reunion is witnessed by the angels who wept at the fall of Adam and rejoiced when Jesus, after His resurrection, ascended to heaven, having opened the grave for all who should believe on His name. Now they behold the work of redemption accomplished, and they unite their voices in the song of praise." The Great Controversy, 647, 648.

#### Role 3. To avenge the blood of his relative – Deuteronomy 19:3, 4.

"Thou shalt prepare thee a way, and divide the coasts of thy land, which the LORD thy God giveth thee to inherit, into three parts, that every slayer may flee thither. And this is the case of the slayer, which shall flee thither, that he may live: whoso killeth his neighbour ignorantly, whom he hated not in the past."

"After Adam sinned, he was doomed to die facing 'eternal death' for "the wage [the price, the ransom] of sin is death." Romans 6:23. "But God commendeth his love toward us, in that, while we were yet sinners, Christ died for us." Romans 5:8.

Christ stood as the Avenger of Blood (Genesis 3:15) and offered His own blood to atone for Adam's sin and the sin of the whole world. Before the foundation of the world, it was decided in the Council of the Most High that, "He hath made him to be sin for us, who knew no sin; that we might be made the righteousness of God in him." 2 Corinthians 5:21.

Not only Christ is the Avenger of Blood, but He is both the priest and the victim, the Avenger and the Blood required to atone for sin and thus paid the ransom for sin which is eternal death with His own blood for "And almost all things are by the law purged with blood; and without shedding of blood is no remission." Hebrews 9:22."

Role 4. To marry his brother's widow in order to have a son for his brother, in case the brother had not got any son to pass his name forth. – Deuteronomy 25:5-6.

"If brethren dwell together, and one of them die, and have no child, the wife of the dead shall not marry without unto a stranger: her husband's brother shall go in unto her, and take her to him to wife, and perform the duty of a husband's brother unto her. And it shall be, that the firstborn which she beareth shall succeed in the name of his brother which is dead, that his name be not put out of Israel."

Israel of Old filled her cup of iniquity when she condemned her Redeemer to die on the cross. "Then answered all the people, and said, His blood be on us, and on our children." Matthew 27:25. "For the woman which hath an husband is bound by the law to her husband so long as he liveth; but if the husband be dead, she is loosed from the law of her husband." Romans 7:2.

Christ's death brought Him apart from ancient Israel and now He can marry the Bride of Revelation 22:17, the Israel of God and those who have believed in Him – which are of the seed of Abraham – the grafted ones: "Come hither, I will shew thee the bride, the Lamb's wife. And he carried me away in the spirit to a great and high mountain, and shewed me that great city, the holy Jerusalem, descending out of heaven from God." Revelation 21:9, 10. "Now to Abraham and his seed were the promises made. He saith not, And to seeds, as of many; but as of one, And to thy seed, which is Christ.... And if ye be Christ's, then are ye Abraham's seed, and heirs according to the promise." Role 5. To receive the restitution if the injured relative had died.

- Numbers 5:8.

"But if the man have no kinsman to recompense the trespass unto, let the trespass be recompensed unto the LORD, even to the priest; beside the ram of the atonement, whereby an atonement shall be made for him."

Numbers 35:9-30 regulates the duties of the 'goel'. The congregation has to judge the case before it puts a murderer in the hands of a 'goel'. More than one witness is needed for conviction. In case of accidental manslaughter, the slayer can save his life by fleeing to a "city of refuge" and staying there for the term of the high priest – who is appointed for his lifetime. Ransom is not accepted for murder. Revenge cannot be taken on the offender's children or parents. Deuteronomy 24:16.

"All who have truly repented of sin, and by faith claimed the blood of Christ as their atoning sacrifice, have had pardon entered against their names in the books of heaven; as they have become partakers of the righteousness of Christ, and their characters are found to be in harmony with the law of God, their sins will be blotted out, and they themselves will be accounted worthy of eternal life. The Lord declares, by the prophet Isaiah: "I, even I, am He that blotteth out thy transgressions for Mine own sake, and will not remember thy sins." Isaiah 43:25."

5 Roles of Our Redeemer Fulfilled by Christ – Identify the True Christ

Role 1. The obligations of the 'Goel' included the duty to redeem the relative from slavery, if the latter had been obliged to sell himself into serfdom. Leviticus 25. – Christ became our Elder Brother – the Nearest of Kinsman – He bought us back from the slavery of sin and from Lucifer the evil one.

Role 2. To repurchase the property of a relative who had had to sell it because of poverty. – Christ's death redeemed the earth and it will be made new at His Third Coming according to Revelation 21:1 and returned to Adam and his descendants as the rightful stewards.

Role 3. To avenge the blood of his relative. – Christ paid the ransom or wage demanded for our transgression of the Law of the Creator: eternal death.

5 Roles of Our Redeemer Fulfilled by Christ – Identify the True Christ

Role 4. To marry his brother's widow in order to have a son for his brother, in case the brother had not got any son to pass his name forth. Deuteronomy 25:5-6 – Christ produced a Seed to Abraham: Himself and through Him we are Abraham's seed and heirs according to the promise.

Role 5. To receive the restitution if the injured relative had died. Numbers 5:8. "He shall see of the travail of his soul, and shall be satisfied: by his knowledge shall my righteous servant justify many; for he shall bear their iniquities." Isaiah 53:11. We are the restitution and by right, we belong to Him, our Redeemer.

"I beseech you therefore, brethren, by the mercies of God, that ye present your bodies a living sacrifice, holy, acceptable unto God, which is your reasonable service." Romans 12:1, 2.
