# Religion of Preference or Religion of Conviction

☐ Religion of Preference:

People who have a religion of *preference* will do great missionary work. They will travel overseas to evangelize if necessary. They will give all their time, money and energy to the cause they have embraced. However, when put under pressure to stand for what they believe, they will falter and give up their faith.

### ☐ Religion of Conviction:

People who have a religion of *conviction* will do all of the above, except when put under great pressure to stand for their faith, even at the risk of prison or death, they will not falter though the heavens fall.

No one can know if they have a religion of *preference* or *conviction* until tested. This important research is to help us prepare to uphold a religion of *conviction* to vindicate our Heavenly Father even at the cost of our lives!

#### Precedent - On trial for Her Beliefs

#### Paivi Rasanen: Finnish MP in Bible Hate Speech Trial

"A former Finnish interior minister has gone on trial for hate speech against gay people, following comments which she says were based on the Bible. Prosecutors accuse Paivi Rasanen of making derogatory comments on three occasions, including in a 2019 tweet showing verses from the Bible. Ms Rasanen denies the charges and says she stands behind her words.

The case is being seen as a test of whether personal religious beliefs can justify controversial language. Announcing the charges in April last year, Finland's state prosecutor said Ms Rasanen had made comments likely to cause intolerance, contempt and hatred towards homosexuals. The charges relate to comments she made on three separate occasions: in an article published online, in a radio interview and in a 2019 tweet which included a photograph of an extract from the Bible.

In the tweet, she questioned why the Finnish Lutheran Church was officially supporting Finland's Pride week. The attached photograph contained verses from the Bible which appear to describe homosexual acts as shameful...."

#### Precedent – On trial for Her Beliefs – continued

#### Paivi Rasanen: Finnish MP in Bible hate speech trial

"The court will have to decide whether citing the Bible can be considered a crime in some cases in Finland. According to prosecutors, an online article by Ms Rasanen which was published in 2004 described homosexuality as a psychosexual development disorder. The politician, who was Finland's interior minister from 2011-2015, arrived at court on Monday [January 24, 2022] holding a Bible and said that she was "honoured to be defending freedom of speech and religion".

"I hope that today it can become clear that I have no wish to offend any group of people, but this is a question of saving people for eternal life," she continued. However, prosecutors say that Ms Rasanen's statements violate the equality and dignity of homosexuals, and therefore go beyond the limits of freedom of speech and religion. In court on Monday, they argued that the case should be based on the secular legal system, not the writings of the Bible.

Although the charges against Ms Rasanen could technically lead to a prison sentence, prosecutors have asked that she receive a fine relative to her income." <a href="https://www.bbc.com/news/world-europe-60111140">https://www.bbc.com/news/world-europe-60111140</a> – January 24, 2022.

#### Worst-Case Scenario In the Court of Law

# 3 Categories of Charges Served Against You Under the New World Religion

- 1<sup>st</sup> Charge: Category relating to Doctrines
- 2<sup>nd</sup> Charge: Category relating to Dates and Calendar
- 3<sup>rd</sup> Charge: Category relating to Statutory Laws

## 1<sup>st</sup> Charge: Category relating to Doctrines

These are the charges served against you under the New World Religion:

- You have taught that Christ's nature was perfect and it is possible for us to be perfect before His return and that people can stop sinning according to the sanctuary teaching.
- You have taught that the body is the temple of the Holy Spirit and the brain nerves are the only medium through which heaven communicates with man and affects his inmost life.
- False Doctrines regarding the state of the dead, prophecy or any related doctrines could also be charged against you.

## Court Evidences – Against Charge #1

- Catholics and Protestants claim this to be a blasphemy as none can be perfect as Christ, since He was perfect like Adam before sin.
- The Catholic Church proves the sinless nature of Christ through Mary's Immaculate Conception.
- Baby's baptism removes the original sin and there is no need to be concerned about the removal of the records of sin under the Great Day of Atonement.
- SDA teachings do not connect the sanctuary of the Bible with the body or the brain.

## 2<sup>nd</sup> Charge: Category relating to Dates and Calendar

These are the charges served against you under the New World Religion:

- You have taught that in 1844, the Anti-typical Day of Atonement took place on October 22<sup>nd</sup>, according to the Biblical Luni Solar Barley Harvest Mosaic Law calendar reinstituted by William Miller and his associates in the 1800's era.
- You have used the Grace Amadon Collection (1939) from Andrews University, Michigan and the Spirit of Prophecy written by E.G. White to teach this heresy.
- You have taught that not only the Feasts of Leviticus 23 must still be observed and calculated according to the Luni Solar Barley Harvest New Moon Horned Crescent calendation, but the weekly Sabbath must also be reckoned using this calendar.
- You have taught that the crucifixion date occurred in AD 31, Thursday, April 26, Julian-Gregorian calendar reckoning, thus the resurrection would have occurred April 28, Saturday, Julian-Gregorian calendar reckoning, according to Biblical, Astronomical, Chronological and Historical data.
- You have taught that Babylon, namely the Catholic Church and apostate Protestantism will fall because Sunday keeping is based on a Sunday resurrection and the resurrection could not and has not occurred on a Sunday.

## Court Evidences – Against Charge #2

- The Rabbinical Jews, who are experts in reckoning their Feast Days according to the equinox, claim that the Day of Atonement in 1844, was September 23<sup>rd</sup>.
- SDA theologians, who have left the SDA Church, claim that nothing happened in 1844 and that Christ entered the Most Holy Place at His ascension. Theologians still in the SDA faith claim that October 22<sup>nd</sup>, 1844 is not that important after all.
- Some theologians agree that the Feasts are calculated from the Biblical luni-solar calendar, but this rule does not apply for the 7<sup>th</sup> Day Sabbath and must be kept Saturday, Gregorian calendar reckoning.
- The Catholic Church and the Protestant Denominations claim that the resurrection date is April 5<sup>th</sup>, 33 AD, a Sunday, making it the sure sign of the authority of the Catholic Church.
- No scholars or astronomers can prove with certainty the true day of Christ's crucifixion.

## 3<sup>rd</sup> Charge: Category relating to Statutory Laws

These are the charges served against you under the New World Religion:

- You have taught that the 10 Commandments along with the Statutes and the Judgments are still binding and are part of the plan of salvation in the sanctuary, including the 7<sup>th</sup> Day Sabbath and the Feasts according to a Luni-Solar Barley Harvest New Moon Horned Crescent reckoning.
- You have taught that homosexuality is an abomination before God, that abortion, euthanasia, divorce and remarriage are not according to God's original plan.
- You have taught and spoken against our Order of Government, upholding separation of Church and State and freedom of conscience and religion.

## Court Evidences – Against Charge #3

- The Catholic Church claims that it has power to change the commandments, the Sabbath and the Feasts.
- Most Protestant denominations claim that those old Mosaic laws were all nailed to the cross including those related to health principles and Christ's Church is no longer under law but grace.
- Homosexuals claim they can be Christian and Christ loves them and accepts them as they are and many Christian Churches accept them as they are without needing to change their lifestyle.
- Abortion and Divorce for any reasons are a matter of choices according to most Christians and openly approve and practice them.
- Under the New World Order, freedom of Conscience is considered a most dangerous heresy.

#### Beware

- You have no right to remain silent.
- If all these charges are proven true, you will be accused of rebellion against the New World Religion and the New World Government and if convicted, you could face imprisonment or the death penalty.
- You must be prepared to answer other questions related to doctrines such as: the state of the dead, baptism by immersion, Bible, Spirit of Prophecy teachings and others.
- The Court may decide if you are entitled to use your confiscated material to defend yourself.
- Rabbinical Jews, Catholic Scholars, Representatives of different Protestant Denominations, former SDA theologians, Pastors and Members in good standing of your Church may be subpoenaed at your trial to witness against you. Muslims, Hindus, Buddhists and persons claiming no association to any faith in particular to whom you taught in the past, may be asked to the witness stand to testify against you.
- You may be required to stand on trial for days and even weeks to answer for you beliefs.

## Purpose

- Although not a reality yet, the possibility of standing on trial for one's beliefs is a matter of time. For some of us, it may already have happened. Whether in a Church Committee setting, through the media, radio, TV, newspapers or Court of Law, some of us have had to answer questions regarding the way we believe and why we believe this way.
- It may not have been under major pressure or difficult circumstances, nevertheless an answer had to be given and we may have found ourselves, nervous, scared, unprepared, overwhelmed. Many claim that when the time comes, the Holy Spirit will bring back to remembrance what we have to say and there is no need to prepare answers in advance. It is not quite what the Bible says.
- Although we are not to prepare what we should say when facing trials, we believe we must study diligently and store all the knowledge and understanding we can while we can. We must pray much in order to give an intelligent and valuable answer to vindicate our Heavenly Father when opportunities arise.
