☐ Civil – Criminal Laws

Precedent – In Prison for His Beliefs – 1

Pastor James Coates – Pastor in Edmonton, Alberta, Canada

The case of Pastor James Coates has become one of the highest profile and most controversial cases of freedom of religion versus COVID-19 health restrictions in Canada.

“The GraceLife case attracted protests and galvanized other church groups to hold services in violation of COVID-19 rules in solidarity with Coates, who maintained his devotion to Christ required violating provincial health orders.

Erin Coates, in an affidavit filed in court, said her husband’s “sincerely held religious belief is that only the Lord Jesus Christ has the authority to prescribe the terms of worship at GraceLife, not any other authority,” and that following COVID restrictions would be disobeying Christ.

“It would amount to fearing man instead of fearing God, or choosing to disobey God by complying with the commend (sic) of an earthly authority that is in opposition to the commandments of God,” Erin Coates writes.”

Precedent – In Prison for His Beliefs – 2

Pastor James Coates – Pastor in Edmonton, Alberta, Canada

“The Edmonton-area pastor, released last week after spending a month behind bars for preaching in violation of COVID-19 regulations, once again appeared at a packed church service on Sunday.

“On Sunday, Rachel Notley, the leader of the New Democrat opposition in the province, said the church must be “shut down.” “So many other congregations across the province have made sacrifices and adapted their services to comply with public health orders,” Notley wrote on Twitter. “The people attending this church are not above anyone else. Their refusal to follow the rules puts others at risk.”

Coates was locked up in mid-February [2021] for breaching bail conditions. He had been charged with violating public health orders, with the church holding in-person services without social distancing and in violation of restrictions that limited capacity to 15 per cent of fire code.”

Are you starting a file as a Self-Represented Litigant (SRL)? (Plaintiff/Applicant)

Paperwork (forms) needs to be prepared by you

- 1) A file will be generated by the courthouse (fees may need to be paid) in order to apply to the court
- 2) The file will need to be “served” or given to the other parties (Defendant(s), Respondents, etc)
- 3) Once the other parties have opportunity to “respond” (if they choose to defend the action/application) - the instituting party may “respond” to any new information raised by the other parties (IF they respond) - This is typically called a “Reply” (Form).
- 4) Once the parties have filed all the initial paperwork, there is a period of “discovery” where documents are exchanged/served, prior to trial. There may also be mediation necessary.

Wanting to respond as a SRL? (Defendant/Respondent)

Paperwork (forms) needs to be prepared by you

- 1) Paperwork (forms) needs to be prepared
- 2) Answer/Response/Defence will need to be “served” (sent to the originating party) then filed at the courthouse. A fee may need to be paid to respond/file at the courthouse.
- 3) Enter “discovery” process.
- 4) Wait for trial.

Christ took the fallen human nature of Adam but not his Perverted Character.

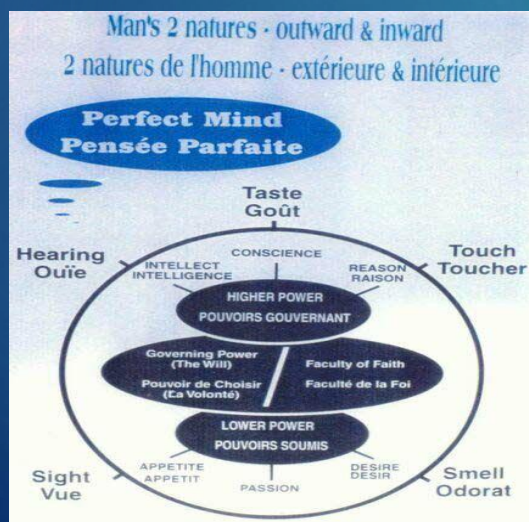

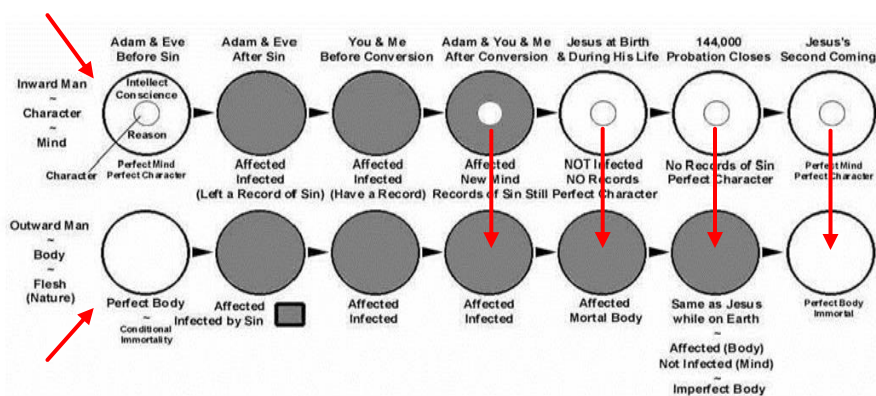

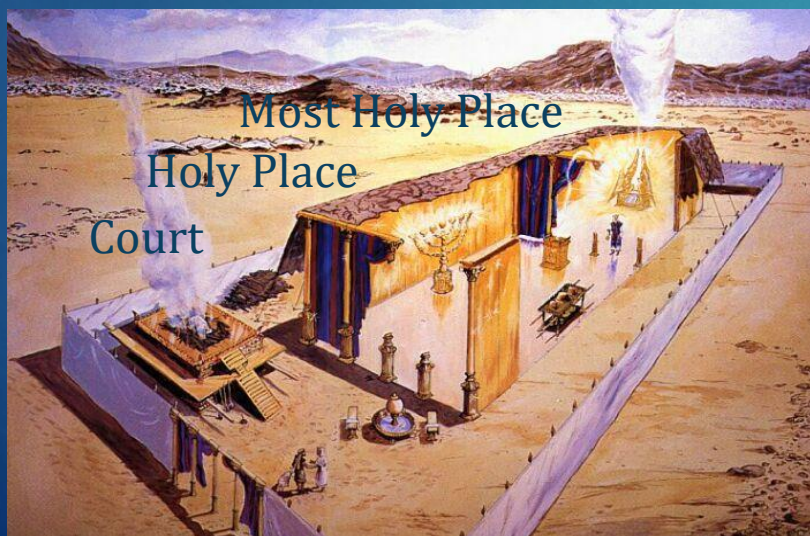
