Worst-Case Scenario In the Court of Law

- ❑ The New World Religion is now in place under the New World Order Government and it is now a crime worthy of death to teach doctrines other than those approved by the New World Religion.
- ❑ You have been charged with the crime of teaching false doctrines and you must appear before the New World Order Court for your beliefs.
- ❑ All your books and materials have been confiscated and you are to appear in Court to stand for yourself as no criminal lawyer wants to defend your case. All your money, properties and assets have been taken over by the New World Order.

Reminder

- You have no right to remain silent.

How to Bring Down False Calendars? By Upholding True Education – Universal Laws

- Question: How to bring down the building of false Calendars?
Answer: The foundation must be attacked: Educational – Religious System
The Mortar and Bricks must be grounded down: Methods of Instruction
- Method to bring False Education – False Calendars Down:

- a. New Moon Horned Crescent: October 13th
- b. Trumpets: October 13 – 1st of the 7th month”

First Century AD and the Calendar

“The Mosaic ceremony connected with the barley harvest, so vital in its control of the [Hebrew year], did not long survive the first century of the Christian era, because of the dispersion of the Jews. The period of persecution which followed the fall of the second temple [70 AD] ultimately brought about a fixed calendar for the Jews --- one that was based upon an entirely different rule of intercalation than the ancient barley harvest regulation [which was replaced by the vernal equinox].

About the 8th century AD, the Karaites arose to oppose the influence of the Rabbanites fixed calendar and to restore the barley harvest schedule as the important index to regulate the leap-year. This controversy over the Hebrew calendar raged for several centuries. Since 1780, the Karaites have been slowly compromising with the Rabbanites on this question and today follow a fixed calendar.”

Synchronism and Chronology of the 2300 days of Daniel 8:14

Explained in Daniel 9:24 – 27

Verse by Verse

DANIEL 8:14 – “Unto 2300 days then shall the sanctuary be cleansed.”

Using the year-day computation principle, literal time is converted to prophetic time when symbolism appears in the prophecy. Daniel 8:14 is a symbolic-prophetic time because animals are used to symbolize kingdoms in Daniel 8.

Therefore, 1 day = 1 year; 2300 days = 2300 years – Numbers 14:34 (40 days = 40 years) – Leviticus 23:27

According to every day – 2300 Day of Atonement – which occurs 1 day each year = 2300 years

Daniel 9: 24 - 27

a. Verse 24: 70 Weeks

"Seventy weeks are determined upon thy people and upon thy holy city, to finish the transgression, and to make an end of sins, and to make reconciliation for iniquity, and to bring in everlasting righteousness, and to seal up the vision and prophecy, and to anoint the most Holy."

Convert the 70 weeks in days x 7 days = 490 days/years

b. Verses 25 to 27 basically break down the 70 weeks:

Verse 25:

"Know therefore and understand, that from the going forth of the commandment to restore and to build Jerusalem unto the Messiah the Prince shall be seven weeks, and threescore and two weeks: the street shall be built again, and the wall, even in troublous times."

1) 7 weeks x 7 days = 49 days/years

2) threescore (1 score = 20) and two weeks =

3 x 20 = 60 + 2 = 62 weeks x 7 days = 434 days/years

Verse by Verse

c. Verse 26:

"And after threescore and two weeks shall Messiah be cut off, but not for himself: and the people of the prince that shall come shall destroy the city and the sanctuary; and the end thereof shall be with a flood, and unto the end of the war desolations are determined." **After 62 weeks or 434 days/years (same 62 weeks as verse 25 or 434 days/years)**

d. Verse 27:

"And he shall confirm the covenant with many for one week: and in the midst of the week he shall cause the sacrifice and the oblation to cease, and for the overspreading of abominations he shall make it desolate, even until the consummation, and that determined shall be poured upon the desolate."

1 Week = 7 days/years

Total: $49 + 434 + 7 = 490$ days/years

which is the same as 70 weeks x 7 = 490 days/years – The next step is to determine the years and times in history when these numbers apply (chronology).

e. Verse 25 states:

"Know therefore and understand, that from the going forth of the commandment to restore and to build Jerusalem unto the Messiah the Prince."

According to the book of Ezra, 3 decrees were sent out to rebuild Jerusalem:

1st Decree: historically one was written by Cyrus to restore the house of God – Ezra 6:1 - 3.

2nd Decree: written by Darius to resume the work on the temple – Ezra 6:8.

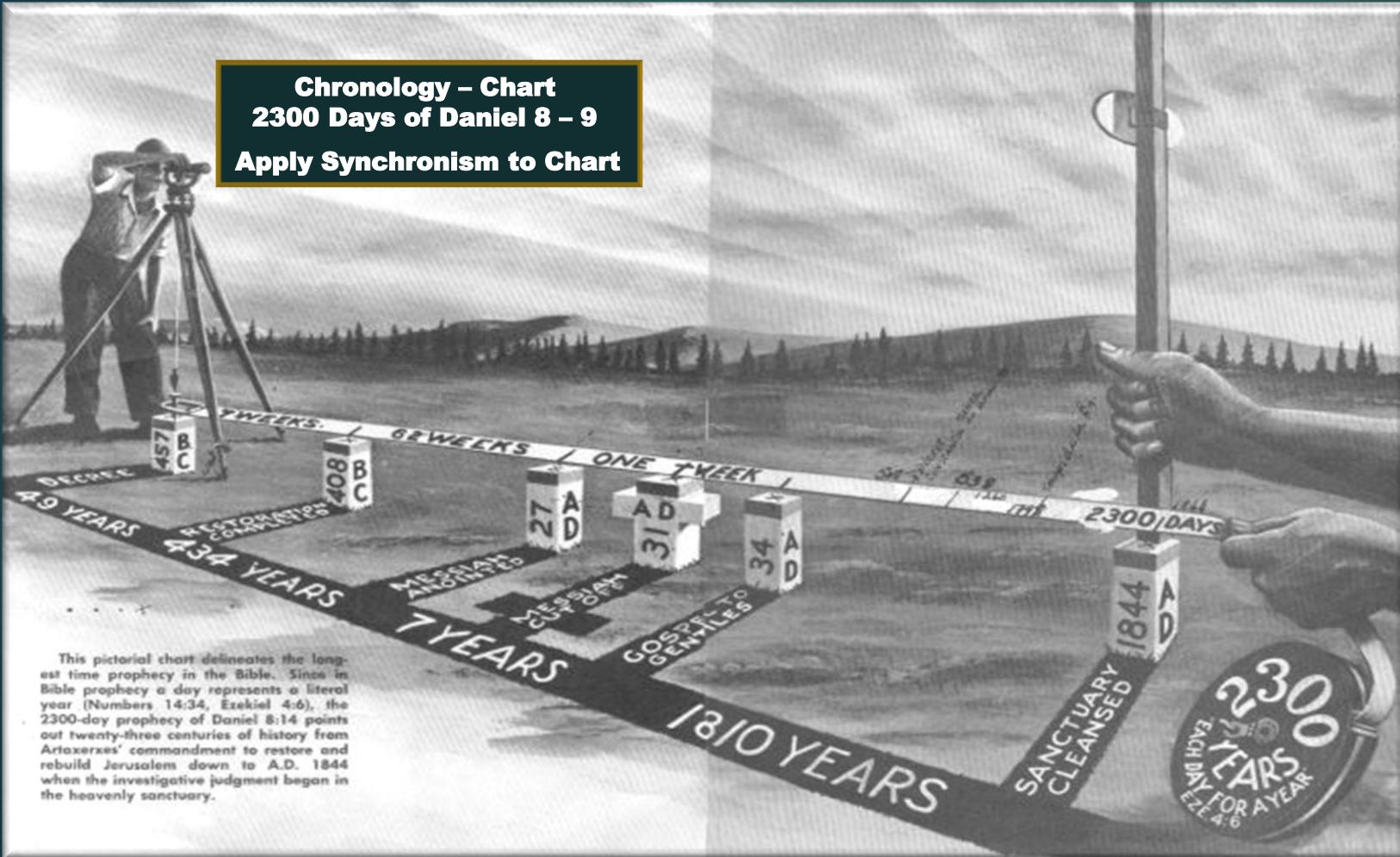
3rd Decree: by Artaxerxes to restore and build Jerusalem – Ezra 7:1-28 which was dated in the fall of 457 BC.

By following carefully the chart in the next slide, Daniel 9:24-27 is demonstrated and Daniel 8:14 determined.



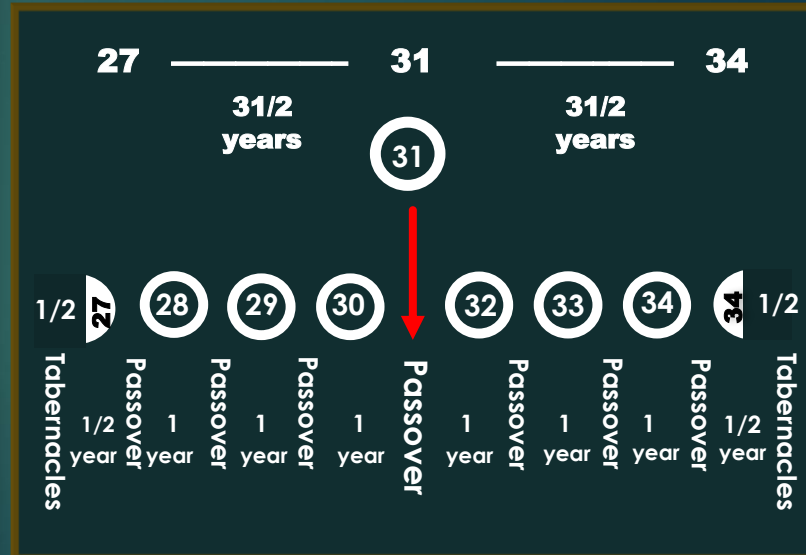
Synchronism and Chronology of the 2300 days of Daniel 8:14 Explained in Daniel 9:24 – 27 Verse by Verse

This pictorial chart delineates the longest time prophecy in the Bible. Since in Bible prophecy a day represents a literal year (Numbers 14:34, Ezekiel 4:6), the 2300-day prophecy of Daniel 8:14 points out twenty-three centuries of history from Artaxerxes' commandment to restore and rebuild Jerusalem down to A.D. 1844 when the investigative judgment began in the heavenly sanctuary.

And the LORD spake unto Moses, saying, Speak unto the children of Israel, and say unto them, Concerning the feasts of the LORD, which ye shall proclaim to be holy convocations, even these are my feasts. 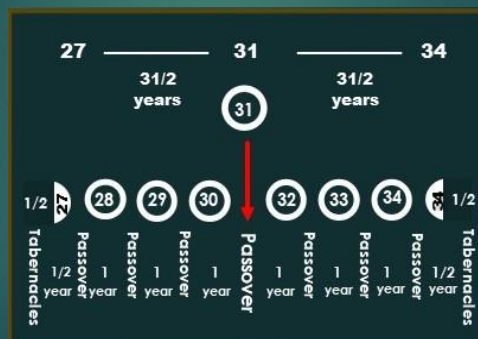

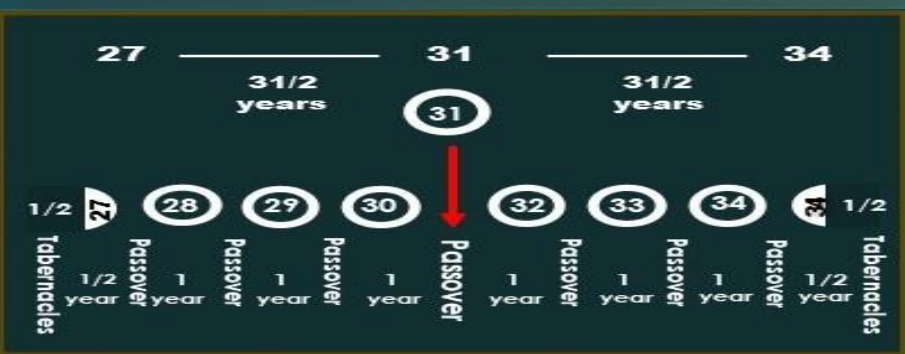
